**Email:** Each student must have an active email account. The University of Florida requires that you obtain a student ID # and a Gatorlink email account as part of your registration process. **Course Description and Learning Objectives:** This is an *asynchronous online*\* course that covers the methods of managing urban pests, such as cockroaches, fleas, termites, flies, stored food pests, and ants. Chemical and nonchemical methods of control will be emphasized, along with safety, laws and regulations. Through completing the course students will be expected to:

- 1. Know the different categories of urban pest insects and how they are targeted based on their biology & behavior.
- 2. Know the steps involved with managing urban pests by chemical, non-chemical and integrated (IPM) approaches.
- 3. Know where and how insecticides are applied in urban settings.
- 4. Know the classes of insecticides used for urban pest management, their modes of action, and how insecticide resistance develops.
- 5. Know the fundamentals of pesticide safety, as well as pest control laws and regulations.

\* "Asynchronous online" means the course will consist of online lectures, labs and learning materials <u>only</u>, to be completed by students independently on their own schedule. However, exams and assignments will be done according to a set schedule. A course schedule is available on the Canvas eLearning site. Students are expected to regularly consult this schedule and be aware of upcoming deadlines.

<u>Critical Thinking Paper Review</u>: Critical thinking & communication for the undergraduate version of the course (ENY3225) will be evaluated by downloading a research paper from the course website, analyzing each of the specific portions of the paper (literature review, objectives, materials and methods, results, and discussion), as well as <u>how the paper connects with specific concepts presented in the course</u>, and submitting an evaluation of the downloaded research paper as a Word document (1000-1500 words).

**Laboratories:** Assignments are multiple choice laboratory activities located at the Canvas website. Students can do the on-line laboratory activities as often as necessary until the due date and will get credit for the best grade obtained for each assessment.

**Specific Evaluations**: Your grade in the course will be based on the points you earn and determined by the percentage breakdown of points earned. The percentage is then applied to the grading scale. Lecture exams 1, 2, and final exam will be timed exams. Final exams (lecture and laboratory) will be comprehensive. The "critical thinking & communication" document will be graded by evaluating the critique of the 5 sections of the downloaded research paper + connecting the paper with concepts in the course, on a scale of 40 points per section.
