COURSE OBJECTIVES

This course provides students with an overview of the ecology, diversity, and agricultural and veterinary importance of insects in the tropics. Insects are the most diverse multicellular organisms in the tropics. Their roles in nature have diversified into most habitats where they are fungivores, herbivores, necrophages, coprophages, saprophages, parasitoids, parasites, and predators. They provide critical ecosystem services such as decomposition, nutrient recycling, pollination, and biological control. Tropical insects are used as bioindicators of ecosystem health and conservation needs.

In this course, students will synthesize information about the tropics, ecology, and entomology. By the end of this course, students will predict how changes to a tropical ecosystem might affect a given insect, and vice versa, with 90% accuracy.

COURSE FORMAT

The narrated PowerPoint presentations form a series of **LECTURES** covering the basic themes listed above. All presentations are available in Canvas through UF eLearning (<u>elearning.ufl.edu</u>). There are **READING ASSIGNMENTS** to provide a broader perspective of the course and provides opportunities for discussion. Participation in **DISCUSSIONS** (via Canvas and Packback) is a critical component of this course. It is recommended that lectures and readings are be viewed before participating in discussion. **STUDENT PRESENTATIONS and PEER REVIEW** of student presentations will allow students to engage with Tropical Entomology topics in more detail. **WRITING ASSIGNMENTS** will consist of an abstract for their presentations and for <u>ENY 5566 only</u>, a short review of a topic of interest.
