**\*\* COURSE DESCRIPTION:** In 2022 the course will consist of one or two one-day field trips and a week-long field trip over Spring Break. These field trips will be to UF research sites, industry research sites, and agriculture production around the state of Florida.

**PURPOSE OF COURSE:** This course is intended to expose students to current research in nematology, entomology, and other plant-protection disciplines, and to expose students to careers in entomology, nematology and related disciplines.

## COURSE POLICIES:

**ATTENDANCE POLICY:** *Attendance on the field trips is mandatory. We will be visiting 6 locations over six days. For each unexcused absence your grade will be reduced*

by 1/6. Excused absences must be consistent with university policies in the Graduate Catalog and require appropriate documentation. Additional information can be found in Attendance Policies.

**\*\*QUIZ/EXAM POLICY:** *There will be no quizzes or exams in this course*

**MAKE-UP POLICY:** *The field trips cannot be made up. For up to two excused absences a makeup assignment will be arranged. If you miss more than two days of field trips you should withdraw from the course.*

**PROFESSIONALISM AND RESPECT POLICY:** *Students are required to behave respectfully and politely toward each other and our hosts during the field trips. When we are on field trip sites, the students must abide by our hosts policies and procedures.*

Additional safety and sanitary materials (goggles, hearing protection, hair nets, etc.) may be required at some sites and will be provided as needed.*

**TRAVEL POLICY:** We will be taking a department 15-passenger van on the field trips. However, you can arrange your own separate transportation if you wish. Similarly, Dr. Crow will arrange for up to four hotel rooms with 2-3 people per room each night over the spring break trip. If you do not want to share a room you can get your own but you will be responsible for the costs. You will need to pay for your own meals.
